

FORUM TERMS & CONDITIONS

By registering and paying for the Energy Consumers Australia 2026 Foresighting Forum to be held in Sydney NSW on 4 & 5 March 2026 inclusive, you are agreeing to the following terms and conditions.

Event fees

Event fees are quoted in Australian dollars (AUD) and include GST. Inclusions are described on the Forum website.

Payment

Registration is not confirmed until payment in full has been received. Energy Consumers Australia reserves the right to refuse entry until such time as the payment is settled if payment is not received prior to the event.

Payment can be made:

- Online by credit card (Visa, Mastercard, American Express). Please note credit card surcharges apply.
- By invoice / electronic funds transfer

Registration cancellations

A substitute delegate can be nominated to attend in your place at any time up to 48 hours prior to the start of the event.

Should you be unable to find a replacement and seek a refund, the following applies:

- 60+ days prior to event start date: A \$50 administration fee applies
- 60 15 days prior to event start date: 50% refund of fees
- Less than 14 days prior to event start date: No refund of fees

Refunds will be processed minus associated booking fees and charges if applicable.

Accommodation cancellations (where applicable)

Accommodation is provided for a small number of supported advocates. All other participants will need to organise their own travel and accommodation.

Where accommodation bookings are made through the registration site these can be cancelled up until 30 days out from the event. Inside 30 days a cancellation fee equivalent to 100% of the booking value will be applicable.



Where a cancellation is unavoidable within 30 days the organisers will try and resell your room to avoid penalty, but no guarantee can be made.

All changes to registrations or accommodation must be made in writing.

Refunds

Where a registrant is entitled to a refund under the provisions of Registration Cancellation on above or special Cancellation provisions (Special Provisions), the amount will be returned in full to the original payer and by the same method as the original payment. Energy Consumers Australia will make its best endeavours to refund within ten (10) business days.

Special Provisions (event cancellation, postponement, enforced restrictions and change of format)

- <u>Event Cancellation:</u> Should the event be cancelled, due to government enforced restrictions, delegates are entitled to a full refund of their registration less any merchant or booking fees incurred during the process. Expenses incurred for travel, accommodation or other costs associated with attendance are the responsibility of the attendee.
- Event Postponement: Should the event be postponed attendee registrations will automatically be transferred to the new date, with attendees having the option to transfer their registration to another party up until 48 hours from the event start date (per the event terms and conditions). The event cancellation and refund provisions in above will take effect from the new confirmed date.
- <u>Enforced Restrictions:</u> Should attendee participation in the event be impacted by government enforced restrictions (such as border closures, lockdown, or mandatory quarantine) a full refund will be given, where the attendee is directly impacted (i.e., located in a state where mandatory lockdown is in affect).
- <u>Change of event format:</u> The organiser reserves the right to change the delivery format of the
 forum at any time should they believe it necessary for the health and safety of event
 participants. Full or partial refunds will be at the organiser's discretion.
